1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and WBW Solicitors (“**Company**,” “**we**,” “**us**,” or “**our**”), concerning your access to and use of the <https://www.wbw.co.uk> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”).
